**Subject: Mixed Gender Teams Kon-tiki 2015**

In order to ensure all Scouts are offered an opportunity to be part of the Kon-Tiki event troops will again be allowed to enter mixed gender teams provided the following conditions are met:

1. Troop Scouters must be fully conversant with and agree to conform to the following National Policies;
  - Child Protection Policy
  - Gender Policy
  - Volunteers Code of Conduct
2. Raft design and construction
  - The raft must be designed in such a way that separate sleeping/changing facilities are provided for both boys and girls.
  - Considering the size of the rafts and the number of participants in the team, it would not be necessary for separate toilets to be provided. However, it should be designed in such a way that there is absolute privacy. The same applies to the sleeping/changing arrangements.
3. The Troop/Group takes full responsibility for the behaviour and discipline of the Scouts on board.
4. Parents of those on board sign a letter of approval for their son/daughter to participate in the mixed gender team.
5. If the aforesaid are not complied with the Kontiki Organiser will have all the authority to withdraw the team from the event.

**Subject: Mixed Gender Teams – Kon-tiki 2015**

When the South African Scout Association agreed to allow girls to become members of the Movement it did so with the proviso that the programme will not be changed and that girls must have access to all our events. At the same time the following policies were introduced to our members:

- Child Protection Policy
- Gender Policy
- Volunteers Code of Conduct

These policies give guidelines to Adult Leaders as well as providing protection for the youth:

Whilst we introduced mixed gender participation at all other events, we had great difficulty deciding whether to allow this at Kontiki. This was only because we could not decide how to deal with the requirement that “we need to provide separate sleeping, changing and ablution facilities for boys and girls”.
